## 1.1.2 Mechanism of internal assessment is transparent and the grievance redressal system is time- bound and efficient

The Institute is affiliated with SPPU and follows the curriculum suggested by them. In 2016, SPPU introduced reforms in the continuous evaluation process, proposing 18 components, and later, in 2019, increased it to 46 components for the continuous assessment of students.

To maintain uniformity and adhere to the academic calendar, the institute has established two CCE components applicable across all subjects. This allows course teachers to design their own CCE scheme, ensuring that the comprehensive concurrent evaluation scheme is completed within a specified timeframe. The final approval of the Comprehensive Concurrent Evaluation scheme, with modifications if necessary, is granted by the Director and Dean academics.

Each CCE component is allotted a minimum of 25 marks. The marks obtained by students in all CCEs are combined and then converted to a total of 50 marks. Rubrics for each CCE component are formulated by respective Course Teachers and shared with students before the CCE examination. This allows students to conduct self-assessments based on the rubric. The institute has also established a mechanism to address grievances in case a student is dissatisfied with the marks obtained.

To manage grievances related to institute-level examinations, an Academic Committee is formed to ensure the smooth and hassle-free conduction of examinations. The examination timetable is communicated in advance to all stakeholders. After the assessment of answer papers, results are displayed on the notice board. Evaluated answer papers are returned to the students, and they are given a two-day timeframe to report grievances. Grievances are addressed on a one-to-one basis by the respective Course Teacher, and the result is declared on the third day after the redressal of all grievances.

- 4) 20% weightage to be given to CCE and 80% to ESE.
- 5) Target attainment level set for all courses is 2.0 on a scale of (0 to 3).
- 6) All teaching staff members are further instructed to maintain the documents accordingly.
