Introduction:

On 6th July 2024, ASM's Institute of Professional Studies and Savitribai Phule Pune University jointly organized a one-day workshop under Quality Improvement Program (QIP) on the Planning and Implementation of the National Education Policy (NEP) 2020 for teaching and administrative staff. The workshop aimed to familiarize participants with the key aspects of NEP 2020 and equip them with the necessary tools and strategies for its effective implementation. The event was held at ASM's IPS Auditorium and saw active participation from educators, administrators, and policy experts.

Objective:

The primary objective of the workshop was to:

- 1. Provide an in-depth understanding of the NEP 2020.
- 2. Discuss strategies for enhancing the teaching-learning process.
- 3. Highlight the importance of skill development, on-the-job training (OJT), research projects (RP), and internships.
- 4. Explain the process of Course Objectives (CO) and Program Outcomes (PO) mapping.
- 5. Facilitate a collaborative approach to planning and implementing NEP 2020 within our institution.

Report:

On the day of workshop, physical Registration started from 9:00a.m. onwards. Tea & Biscuits were arranged for all the participants. Dr. Madhura Shukl did anchoring at the beginning of Inauguration Session which was started at 10:00 a.m. with lightning of lamp, Saraswati Vandana and University Song. Then Dr. Vikas Barbate sir briefed about the workshop. Then Director of ASM's IPS Dr. Sudhakar Bokephode sir felicited Chairman of ASM Group of Institutes Dr. Sandeep Pachpande Sir. Session 1: from 10:30 a.m. to 12:00 p.m. -- Teaching-Learning Process by Prof. Dr. Prakash Chaudhary - Vice Principal, Professor and Head of Department of Business Laws, in Ness Wadia College of Commerce, Pune.

The first session focused on the transformative changes proposed by NEP 2020 in the teaching-learning process. The key points discussed included:

- ⇒ Holistic and Multidisciplinary Education: Emphasis on providing a broad-based education that includes arts, humanities, and sciences, aiming for holistic development.
- ⇒ Student-Centric Pedagogy: Adoption of teaching methods that prioritize active learning, critical thinking, and creativity. The session highlighted the need for interactive and participatory teaching styles.
- ⇒ Technology Integration: Encouraging the use of digital tools and resources to enhance learning experiences and bridge educational gaps.
- ⇒ The session concluded with a Q&A segment where participants shared their insights and concerns, leading to a productive discussion on best practices and innovative teaching methodologies.

Session 2: from 12:00 p.m. to 1:30 p.m. -- Skill Development-OJT, RP & Internship, and Curriculum Activities by, Dr. Ramdas Sonawane - Professor of Department of Mathematics, Statistics and Computer Applications, in Ness Wadia College of Commerce, Pune.

The second session was dedicated to the practical aspects of skill development and experiential learning. Key topics covered were:

- ⇒ Skill Development: The necessity of aligning curriculum with industry requirements to equip students with relevant skills. The session stressed the importance of vocational education and training.
- ⇒ On-the-Job Training (OJT): The role of internships and apprenticeships in providing handson experience. Strategies for forging partnerships with industries and organizations were discussed.
- ⇒ Research Projects (RP): Encouraging undergraduate and postgraduate research projects to foster a research-oriented mindset among students.
- ⇒ Curriculum Activities: Integration of co-curricular and extracurricular activities to ensure the all-round development of students.

Participants engaged in clearing doubts in Question and Answer session on implementing effective OJT and internship programs within their departments.

ASM's IPS had arranged lunch for all the participants from 1:30 p.m. to 2:15 p.m.

Session 3: CO-PO Mapping by, Dr. Kajal Maheshwari - Associate Professor at PCET's S.B.Patil Institute of Management.

The third session focused on the critical aspect of CO-PO mapping. Curriculum Outcomes (CO) and Program Outcomes (PO) are essential for measuring the effectiveness of educational programs. The session covered:

- ⇒ Understanding CO-PO Mapping: Explanation of the concepts and their significance in curriculum design and assessment.
- ⇒ Steps for CO-PO Mapping: Detailed guidelines on how to map curriculum outcomes with program outcomes, including the use of matrices and rubrics.
- ⇒ Assessment and Feedback: Methods for evaluating the achievement of CO and PO, and the importance of continuous feedback mechanisms for improvement.

Interactive exercises were conducted to help participants practice CO-PO mapping using real-life examples from their courses.
